From [Chamber Business News](#): Arizona's top tax bracket will increase 77.7% according to a summary adopted last Thursday by a legislative panel assessing the effects of the so-called "Invest in Ed" ballot initiative. The summary approved by Legislative Council, which is comprised of state representatives and senators from each party, explains that the initiative seeks to assess a 3.5 percentage point increase on the current 4.5% tax rate on individual income exceeding \$250,000 annually and married couple income exceeding \$500,000 annually, resulting in an 8% tax rate on that income, a 77.7% increase over the current rate.

The summary also says that the tax increase will apply to income from small businesses that are organized as pass-through entities, like sole proprietorships and limited liability companies. Such small businesses pay their income taxes on the individual portion of the tax code, not the corporate tax code.

The Legislative Council summary will appear in a pamphlet that is prepared by the Office of the Secretary of State and mailed to voters before the fall election. [Read the entire article here.](#)
